APPLICATION

All those who wish to attend the Colloquium are invited to fill in the enclosed application form and return it before September 30th, 2023.

LECTURES

The participants who wish to present lectures should send the application form with the title and a brief summary on the chosen subject (200 words). The summary of papers must be submitted by July 31st. The Scientific Committee will examine the submitted papers and will notify all participants if accepted by August 31st, 2023. The lectures should not exceed 30 minutes in order to leave space for debate. The deadline for sending the final texts of the papers is September 30th, 2023.

Originals should not exceed 25 pages (1850 words in total) and will have a one page abstract. Participants who wish to use a multimedia device must notify the Secretariat before August 31st, 2023.

The lectures must be in one of the following languages: Italian, Spanish, French, English or German.

EXCURSIONS

Participants and accompanying persons will have the opportunity to visit some of the most important places and monuments in Madrid.
